METER TAMPERING

Doña Ana MDWCA shall have the right to disconnect or refuse to connect or reconnect any utility service where there is evidence that Doña Ana MDWCA metering or monitoring devices have been tampered with, damaged or stolen. Doña Ana MDWCA shall immediately disconnect the water meter and assess the user \$300.00 per meter for tampering, damaging and/or theft of equipment. The tampering, damage and or theft assessment shall be paid in full and any delinquent balance paid before service is reactivated or reconnected.

CURRENT PROJECTS-DONA ANA VILLAGE LIFTSTATION AND FORCEMAIN

This project is for the restoration of the current lift station, force main and related infrastructure. The system was initially built in 1997 by Dona Ana County, then handed down July 2017 to Dona Ana MDWCA. Wastewater from the Village of Dona Ana collection systems reaches the Dona Ana Life Station through gravity sewer lines. The wastewater gathers in a wet well. When the well fills to specific depths the lift station initiates and pumps the gathered wastewater through the force main alignment around 3.3 miles southeast. The funding for this project is through the New Mexico Finance Authority Colonias Infrastructure Board.

The lift station has widespread degrees of erosion and deterioration as well as issues with functionality. The current polyvinyl chloride "T-Locks" style liner has separated at a few seams leaving the concrete wall of the wet well exposed to corrosive elements. Also, the concrete ceiling does not have any defensive covering. The existing electoral junction box is also weathered and hazardous.

In addition the ductile iron force main is ineffective in various areas requiring the replacement of sections of pipe. The profile of the force main has a high point located at the southern end of Cristo Rey Street as the line exits the Village. Following the end of the pumping cycle, the section of force main between the lift station and high point should remain full. The excess 11,600 feet of force main slowly drains into the discharge manhole located at the north side of Los Vendos Subdivision. The full line has been destroyed by sulfuric acid which has deteriorated the existing ductile iron force main.

SUGAR COOKIES

Ingredients

- ♦ 2 1/4 cups flour
- ♦ 3/4 cup sugar
- ♦ 1/2 tsp baking power
- ♦ 1 tsp salt

- ♦ 3/4 cup butter
- ♦ 1 tsp vanilla extract
- ♦ 1/2 tsp almond extract

Cream Cheese Frosting

- ♦ 2 ounces cream cheese
- ♦ 2 tsp vanilla extract
- ♦ 4 cups powered sugar
- ◆ 1/2 cup butter (softened)
- ♦ In a bowl, beat butter until smooth for about one minute. Add in sugar, beat 2 minutes. Add egg, vanilla, and almond extract, beat two minutes.
- In another bowl, mix together flour, baking power, and salt. Slowly add the butter mixture and beat all together until the dough forms. Chill in the refrigerator for two hours.
- Pre-heat oven 350 degrees. Roll dough out to 1/4 inch thick. Cut out sugar cookies with your favorite cookie cutter, then transfer onto a baking sheet. Bake 9-11 minutes.

Cream Cheese Frosting

Beat together butter and cream cheese until smooth, add vanilla extract and powered sugar beat 2 minutes. Frost your cooled cookies. Use food coloring to give color (optional).
