STUFFING RECIPE


Ingredients:

- ♦ 1 loaf cornbread
- ♦ 1 loaf Italian bread
- ♦ 1 loaf French bread
- ♦ 1 large onion, diced
- ♦ 5 stalks celery, diced
- ♦ 1/2 bunch parsley
- ♦ 1/2 cup butter (1 stick)
- ♦ 6 cups low-sodium chicken broth
- ♦ 1/2 tsp. dried basil
- ♦ 1/2 tsp. ground thyme
- ♦ 1 tbsp. fresh rosemary, finely minced
- ♦ salt
- pepper

Directions:

- Cut all the bread into 1-inch cubes and lay them out on sheet pans. Cover with a dish towel and let them dry for 48 hours until they are dry and crisp.
- Melt the butter in a large skillet, add the onions and celery and cook for 3-4 minutes.
- Add the broth, parsley, rosemary, basil, thyme, salt and pepper and stir.
- Put all the bread crumbs in a large bowl and slowly ladle in the broth mixture, tossing as you go until the dressing has the moisture level you want. Taste and add more seasonings as needed.
- Pour the dressing into a large casserole pan and bake for 20 to 30 minutes at 375 degrees until golden and crisp on top.

New Mexico Law requires everyone to call NM811 two days prior to starting any excavation project, no matter the size. NM811 is a free service for everyone to use to help locate underground utility lines. Examples are building a fence, landscaping, installing a pool, installing a sprinkler system, etc. Once the lines are marked you can safely begin your dig.
